uplands. Some of the property within the review area is currently part of a sand and gravel mining operation and there are multiple man-made borrow pits with linear features connecting them. An OHWM was observed in all of these features, but there was no connection to the downstream TNW. The man-made borrow pits were determined to be entirely excavated out of uplands. The linear features connecting the borrow pits to one another were determined to be non-jurisdictional ditches, excavated entirely out of uplands and draining only uplands. No other potentially jurisdictional features were observed during the investigation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. **ADDITIONAL COMMENTS TO SUPPORT JD:** Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. A prevalence of hydrophytic vegetation, multiple hydrology indicators, and hydric soils were observed within the flagged wetland boundary which was verified. Wetlands flow is to an offsite tributary identified on USGS Quad Maps as Naked Creek. The tributary was determined to be a perennial RPW and tributary of the Great Pee Dee River (TNW). Wetland#1 is adjacent and directly abutting the perennial RPW. Flow of the off-site tributary, Naked Creek was determined to be perennial due to the presence of the flow of water outside of the wet season under drought influenced climatic conditions and by identification of many indicators of perennial flow observed at Williamette Road, east of the review area and downstream of the adjacent wetlands. Stream geomorphic indicators of perennial flow were a well-defined natural channel within bed and banks and presence of an OHWM. The bottom channel was approximately 15' wide at the bottom and strong flow was observed during the time of the site visit. Throughout the center of the channel a lack of vegetation was evident due to inundation to approximately 4' and the flow of water. A sandy bottom was observed within the stream channel with some sediment sorting, drift deposits, and depositional bars noted downstream of the culvert. Topographic maps depict this reach as a blue line stream called Naked Creek. Aerial photos show the presence of inundation of water and also show that the feature continues onto adjacent property where it turns to the east, entering into a wetland system which intercepts the OHWM of the Great Pee Dee River (TNW). One isolated wetland described as "Wetland#2" was assessed within the review area totaling 1.5 acres and was determined to be isolated and is described on Form 2 of 2. A series of linear features were observed on the subject property which were determined to have no OHWM and were excavated out of uplands and draining only uplands. Some of the property within the review area is currently part of a sand and gravel mining operation and there are multiple borrow pits with linear features connecting them. An OHWM was observed in all of these features, but there was no connection to the downstream TNW. The borrow pits were determined to be entirely excavated out of uplands. The linear features connecting the borrow pits to one another were determined to be non-jurisdictional ditches, excavated entirely out of uplands and draining only uplands. No other potentially jurisdictional features were observed during the investigation.
