- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One (1) isolated wetland (Wetland#2 = 1.5 acres) was assessed within the review area. A review of infrared aerial photographs, soil maps, and NWI maps prior to the site visit determined that this area was a potentially jurisdictional wetland. The wetland boundaries were verified during the site visit on May 2, 2012 using the 1987**

Delineation Manual. Hydric soils, a prevalence of hydrophytic vegetation, and hydrology indicators such as moss trim lines, the presence of oxidized rhizospheres on living roots, and saturation within the upper 12" were observed. The wetland was determined to be a depressional area surrounded entirely by uplands consisting of upland soils and fallow farm fields. No hydrology indicators were observed within the surrounding uplands. One linear feature was discovered within Wetland#2 which continued to the east into the uplands. The linear feature had bed and banks but did not have an OHWM. The linear feature ended abruptly in uplands. No surface or shallow subsurface hydrologic connections exist between this wetland and jurisdictional wetland (Wetland#1) described on Form 1 of 2 or the offsite tributary (Naked Creek) or any other off-site aquatic resources. The depressional wetland area retains water within the wetland boundary and has no evidence of a chemical or biological connection to other waters of the US; therefore, "Wetland#2" was determined to be non-jurisdictional. A series of man-made non-jurisdictional ditches and man-made borrow pits were determined to be non-jurisdictional and are described on Form 1 of 2. No other potentially jurisdictional features were observed during the investigation.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. A prevalence of hydrophytic vegetation, multiple hydrology indicators, and hydric soils were observed within the flagged wetland boundary which was verified. Wetland#1 was determined to be jurisdictional and is described on Form 1 of 2. One (1) isolated wetland (Wetland#2 = 1.5 acres) was assessed within the review area. A review of infrared aerial photographs, soil maps, and NWI maps prior to the site visit determined that this area was a potentially jurisdictional wetland. The wetland boundaries were verified during the site visit on May 2, 2012 using the 1987 Delineation Manual. Hydric soils, a prevalence of hydrophytic vegetation, and hydrology indicators such as moss trim lines, the presence of oxidized rhizospheres on living roots, and saturation within the upper 12" were observed. The wetland was determined to be a depressional area surrounded entirely by uplands consisting of upland soils and fallow farm fields. No hydrology indicators were observed within the surrounding uplands. One linear feature was discovered within Wetland#2 which continued to the east into the uplands. The linear feature had bed and banks but did not have an OHWM. The linear feature ended abruptly in uplands. No surface or shallow subsurface hydrologic connections exist between this wetland and the onsite jurisdictional wetland (Wetland#1) or the offsite tributary (Naked Creek) or any other off-site aquatic resources. The depressional wetland area retains water within the wetland boundary and has no evidence of a chemical or biological connection to other waters of the US; therefore, "Wetland#2" was determined to be non-jurisdictional. A series of man-made non-jurisdictional ditches and man-made borrow pits were determined to be non-jurisdictional and are described on Form 1 of 2. No other potentially jurisdictional features were observed during the investigation.
