Explain: **A review of the NWIs shows two wetlands (PSS4/1Ad) located within the northwestern portion of the site. These potential wetlands are depicted as non-hydric soils (Lynchburg) on the soil survey and are not depicted on the**

topographic map or aerials. During the site visit, these two areas were viewed and determined to not be wetlands based on the absence of hydric soils and hydrology indicators.

According to the topographic map, a solid blue line indicative of a tributary originates near the center of the northeastern property line and continues southeast toward Hwy. 76. After crossing Hwy. 76, this blue line flows into Alligator Branch. During the site visit, the eastern property boundary was investigated and no linear features were observed in this area. However, other linear features, which are depicted on the aerials, were observed during the site visit. These linear features originate within the agricultural field located on the southeastern half of the property and are excavated out of uplands. Trees were observed growing in the bottom of these linear features in several locations, and they were completely covered in dry leaf litter and debris with no OHWM observed. Because of the lack of any indicators of flow within the on-site linear features, they were determined to be non-jurisdictional ditches and they are depicted and labeled on a drawing in the file.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of the aerials, topographic map, NWIs and a site visit, the project area was determined to have no wetlands or other waters of the US present. A review of the NWIs shows two areas mapped as wetlands (PSS4/1Ad) located within the northwestern portion of the site. These potential wetlands are depicted as non-hydric soils (Lynchburg) on the soil survey and are not depicted on the topographic map or aerials. During the site visit, these two areas were viewed and determined to not be wetlands based on the absence of hydric soils and hydrology indicators.**

According to the topographic map, a solid blue line indicative of a tributary originates near the center of the northeastern property line and continues southeast toward Hwy. 76. After crossing Hwy. 76, this blue line flows into Alligator Branch. During the site visit, the eastern property boundary was investigated and no linear features were observed in this area. However, other linear features, which are depicted on the aerials, were observed during the site visit. These linear features originate within the agricultural field located on the southeastern half of the property and are excavated out of uplands. Trees were observed growing in the bottom of these linear features in several locations, and they were completely covered in dry leaf litter and debris with no OHWM observed. Because of the lack of any indicators of flow within the on-site linear features, they were determined to be non-jurisdictional ditches and they are depicted and labeled on a drawing in the file.
