If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This Perennial RPW was not observed during the on-site inspection; however, based on aerial photography, soil survey, and NWI maps, this stream was determined to be a Perennial RPW. This Perennial RPW is identified as a blue line stream on the USGS topographic maps, approximately 1.93 river miles in length, and has a drainage area comprised of approximately 1,343 acres of abutting palustrine, forested wetlands (PFO1A) as identified on the NWI maps. Surrounding this drainage area is a mixture of upland forests, rural homes, and agricultural fields. Approximately 90% of the unnamed Perennial RPW flows through a hydric soil unit, identified on the soil survey as**

**Pantego sandy loam, Ogeechee fine sandy loam, Ellore loamy fine sand, and Daleville silt loam. This Perennial RPW and its abutting wetlands are contiguous with Four Hole Swamp further to the north, a RPW which flows directly into the Edisto River, a TNW.**

NWI maps identify a large palustrine, Forested Wetland that abuts the Perennial RPW and encompasses the entirety of Wetland 1 and runs 600 linear feet north of Wetland 3. Soil Survey maps identified a hydric soil unit, Daleville Silt Loam, that runs through both Wetlands 1 and 3 and connect further north to the Perennial RPW.**
