This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

In addition, topographic maps depict the tributary as a solid blue line feature which typically represents a tributary with perennial flow and the Horry County Soil Survey depicts the feature as tributary with a flow regime of perennial.

ADDITIONAL COMMENTS TO SUPPORT JD: PRPW 2 located within the project area contains 1,550 linear feet of tributary determined to be a waters of the United States subject to the jurisdiction of this office. The jurisdictional tributary is considered a natural feature of which the run of the tributary comprises the southwest boundary line of the project area. Wetlands were determined to be directly abutting the onsite tributary. In addition, the project area contains an additional tributary documented on basis form 1 of 2.
