

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

normal climatic conditions. Stream geomorphic indicators of perennial flow observed were: continuous bed and bank, the channel within bed and banks had a firm sandy bottom clear of vegetation and debris, sediment bars/deposition bars located adjacent to the channel which is evidence of perennial flow. In addition, hydrologic indicators observed were: Leaves within the channel being continuously washed downstream, wrack lines consisting of organic debris and trash, and an even distribution of substrates (longitudinally) in the stream channel. The tributary flows and outfalls directly into the TNW (AIWW). In addition, topographic maps depict the tributary as a solid blue line feature which typically represents a tributary with perennial flow and the Horry County Drainage Study of 1976 depicts the tributary on Sheet 11 as a Main Drainage Canal (M-28).
