**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Water was observed flowing at the time of the site visit. Tributary appears to be a man-altered feature with an existing upland spoil berm located to the north of and immediately adjacent to the tributary. Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow observed were: continuous bed and bank; the channel within bed and banks had a firm sandy bottom clear of vegetation and debris; sediment bars/deposition bars located adjacent to the channel which is evidence of perennial flow. In addition, hydrologic indicators observed were: Leaves within the channel being continuously washed downstream; wrack lines consisting of organic debris; flowing water at time of site visit and trash; and an even distribution of substrates (longitudinally) in the stream channel. The tributary is depicted on the USGS topographic map as a solid blue line which typically represents a tributary with a perennial flow regime. The Horry County Soil Survey, page 70 depicts the tributary with a symbol which typically represents a flow regime of intermittent. The tributary outfalls directly into the Waccamaw River(TNW).

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area contains 481.09 linear feet of a man-altered tributary determined to be a waters of the United States subject to the jurisdiction of this office. The jurisdictional tributary is considered man-altered and exhibits a perennial flow regime based on indicators observed during the April 19, 2012 site visit. In addition, the project area contains a 0.52 acre wetland (wetland 2) and a 3.42 acre wetland (wetland 1) determined to be directly abutting (adjacent) the onsite tributary. Limits of jurisdiction for the onsite tributary was established by a well defined OHWM. Limits of jurisdiction for the onsite wetlands were established by the 1987 Corps Delineation Manual. The site visit was performed under normal climatic conditions where water was observed flowing within the tributary and wetlands were saturated to the surface. Total project area consists of 19.97 acres with 481.09 LF of tributary and 3.94 acres of freshwater wetlands.**
