subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps do not depict any wetland symbols or blue lines (linear features) on the subject property or within close proximity to the isolated wetlands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

tributary that was excavated sometime after 2007. The tributary is relatively straight and regularly maintained. It is not depicted on topographic maps. However, it is visible on recent aerial photos. The tributary did not exist when the previous delineation was performed (SAC# 2007-01570-3JT, Letter dated 8-2-2007). Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom, OHWM (line impressed on the bank), clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream. Flowing water was observed during the site visit.

The tributary is relatively straight and regularly maintained. It is not depicted on topographic maps. However, it is visible on recent aerial photos. The tributary did not exist when the previous delineation was performed (SAC# 2007-01570-3JT, Letter dated 8-2-2007). Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom, OHWM (line impressed on the bank), clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream. Flowing water was observed during the site visit.

The isolated wetlands were coordinated with EPA & HQ on 4-25-12.
