C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A Wetland boundaries were established using the 1987 Wetland Delineation manual. The onsite tributary flows through onsite wetlands with a clearly defined OHWM, bed and banks, and open channel with a firm sandy bottom. Flowing water was observed periods of below normal rainfall in addition to fauna (minnows, amphibians, etc). This tributary is situated inside wetlands and that continues offsite, under HWY 17, and discharging into the Main Creek.

Soils onsite are as follows: Chipley soils (non-hydric) & Lakeland soils (hydric)
