C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The southern end of the site is barren, with bright sandy soils, and is used for commercial services. The majority of the rest of the site had been cleared or was being cleared at the time a site visit was attempted -. Large equipment was on-site removing vegetation and vegetation was down all over the site. Therefore, a comprehensive site visit was not conducted at that time. An additional site visit was conducted with the consultant a few days later. The site was under construction, but disturbed soils were bright indicating a lack of wetland hydrology. Based on the site visit, information provided by the consultant, and

information obtained from aerial photos and quad sheets, it is the determination of this office that there are no wetlands or Waters of the U.S. on the subject site (Lot 2A, as depicted on the plat).
