sheets depict this as a oval shaped, isolated wetland. Corps employees and the consultant approached the wetland from the west and walked around the site in a clockwise direction. At the southern end, the wetland connected to a shallow ditch/swale that extended to the northeast. However, there was no connection of the ditch/swale with any other on-site or off-site ditch/tributary/conveyance. In addition, the wetland is surrounded on the west, north and east by crop fields and there was no evidence of overland sheet flow, no evidence of matted vegetation, or indication of any surface or subsurface connection to any other wetland or Water of the U.S. Further, the wetland in question is not connected to any navigable water or any tributary to navigable water, or contiguous or adjacent to any surface tributary system, and is not an interstate water or connected thereto in any fashion.

In addition, there are 23, 132 LF of non-jurisdictional linear features that criss-cross the subject tract. The site is predominantly agricultural and these features are man made ditches that do not exhibit bed and banks, ordinary high water marks, and typically carry flow only related to storm water events. These are therefore not jurisdictional. Five of these linear features (DF-B, DF-C, DF-F, DF-H, and DF-J), totaling 6,693 LF, are discussed on Forms 1 and 2 as they provide hydrologic connections between wetlands and jurisdictional downstream waters.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Five of these linear features (DF-B, DF-C, DF-F, DF-H, and DF-J), totaling 6,693 LF, are discussed on Forms 1 and 2 as they provide hydrologic connections between wetlands and jurisdictional downstream waters.
