Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The non-jurisdictional wetland is a 2.054 acre, isolated, palustrine wetland. This wetland is located at the southeast perimeter of the property site. Corps personnel and the consultant both circled the wetland. This wetland is 790 linear feet away from the closest Water of the U.S., a perennial stream to the south, and is surrounded completely by uplands. A prior jurisdictional determination (SAC 2007-1276-2JY) was performed on the property abutting the**

south and east borders of this isolated wetland and documented no wetland, Water of the U. S., or ditch stemming from the isolated wetland. There exists no physical connection to any jurisdictional wetlands, no apparent chemical connection, or any apparent biological connection, including any evident ecological interconnectivity. This wetland is isolated and is not subject to Clean Water Act jurisdiction.

A non-jurisdictional pond of water (approximately 0.63 acres) located near the south end of the property was constructed solely in uplands and is draining only uplands. The agent commented that this pond was the attempted creation of an ideally more successful pond by the means of the previous property owner. Corps personnel circled the pond and found no hydrological connection between the pond and any nearby wetlands. The pond possesses no culvert connections or other drainage features that would presume an underground hydrological connection and no evident chemical connection. The pond also possesses no matted down vegetation along its perimeter, wrack line, or other evidence of a surface flow of water to outside Waters of the U.S. This pond is not considered a Water of the U.S. and is not subject to Clean Water Act jurisdiction.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

This property contains 7.15 acres of freshwater wetlands that, based on an on-site inspection and a review of aerial photography and soil information, were

determined to be jurisdictional under the Clean Water Act. This 7.150 acre wetland system is a part of a larger wetland system deemed jurisdictional and connected to the Goose Creek Reservoir by means of a perennial stream, SAC#2007-1276-2JY.
