However this ditch runs along Porcher Bluff Road through the front yard of a house site, does not exhibit a bed and bank nor an OHWM and is not a jurisdictional Water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide data and rationale indicating that tributary is perennial: Based on information provided on quad sheets, the tributary extends east of the subject property, providing drainage through upland and wetland areas. It flows across the subject property to the southeast, turning northeast off-site, and flowing into the tidal waters of Copahee Sound. On-site, the tributary is ~50' wide on the western end with alligatorweed, pickeral rush, cattails, and willows. It expands to ~75' wide on the eastern end with predominantly alligatorweed in it. There was water in the tributary and the alligatorweed was extended in the direction of downstream flow, indicating that water flows with sufficient velocity to stretch the alligatorweed weed in a downstream direction. In addition, the trib exhibits an OHWM where bank vegetation grows out over the water, but not into the water. Further, the data sheets

submitted by the consultant found that the ditch was inundated in February 2012 during his site visit and exhibited an OHWM at that time as well as incised banks. Lastly, the tributary is depicted on the quad sheets as a blue line stream.

B. ADDITIONAL COMMENTS TO SUPPORT JD: No on-site wetlands were identified on the subject tract as it was predominatnly a grassed yard with a few trees - Pnus taeda, Quercus virginiana, and Magnolia grandiflora. There is a roadside ditch that is not a jurisdictional feature as it only drains the roadway and upland areas. The only jurisdictional featureon the tract is a large tributary located at the back of the property that flows to Copahee Sound. This feature exhibits a bed and bank, OHWM, and was inundated with water during February 2012 when the consultant was at the site and in June when Corps personnel visited the site. Based on a site visit, aerial photos, quad sheets, and soil survey information, this drainage feature is jurisdictional.
