Explain: **There is a small 0.1887 acre palustrine, depressional wetland located on the west side of the property near the northwestern corner of the site. It is 980 feet from the nearest jurisdictional wetland. Personnel approached the**

wetland from south and walked around it in a clockwise direction. Historically, it is expected that this wetland extended off site. However, currently, the adjacent property has been developed, and there are no linear conveyances extending from the wetland in any direction. There is an obvious rise in elevation around this wetland and no evidence of overland sheetflow, no evidence of matted vegetation, or indication of any surface or subsurface connection to any other wetland or Water of the U.S. Further, the wetland in question is not connected to any navigable water or any tributary to navigable water, or contiguous or adjacent to any surface tributary system, and is not an interstate water or connected thereto in any fashion.

In addition, there is a non-jurisdictional linear conveyance near the southern boundary of the tract that provides a hydrologic connection from jurisdictional wetland B to C. It extends from the southern edge of Wetland B to the northern edge of Wetland C which continues off-site and is part of a larger wetland system that is contiguous with and abuts the Ashley River, a TNW. The linear conveyance between Wetlands B & C is a shallow, approximately 0.5' deep swale/ditch. There were wet areas in it from a recent rainfall, but there was no flow, and it had leaves in it that had not washed down stream. It did not exhibit a bed and bank or an OHWM. Consequently, it is not a jurisdictional feature.

### **SECTION III: CWA ANALYSIS**

Summarize rationale supporting determination: The on-site wetlands at the south end of the site (Wetlands B and C) are hydrologically connected via a man made linear feature. This non-jurisdictional linear feature extends from the southern edge of Wetland B to the northern edge of Wetland C which continues off-site and is part of a larger wetland system that is contiguous with and abuts the upper reaches / head waters of the Ashley River, a TNW. Wetland B is hydrologically connected to Wetland C and the off-site larger wetland system through the non-jurisdictional linear feature and is therefore also adjacent to the Ashley River.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There are 2 non-jurisdictional features on the 24.7404 acre tract. Non-jurisdictional Wetland A, at the northwest corner of the property, is merely a depressional wetland with no connection to any other wetland or water of the U.S. At the southern end of the site, there is a ~100' linear conveyance that connects two jurisdictional wetlands but is not jurisdictional

itself. Based on a site visit, and review of aerial photos, quad sheets, and the soil survey, it is the determination of this office that neither of these features is jurisdictional.
