C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Although the subject site is mapped as a hydric soil (Meggett), the other two criteria of hydrophytic vegetation and evidence of hydrology are lacking. Some fill was noted on Lot 2A but it does not appear to be recent. The NWI shows the site as uplands. No wetlands were found on the subject property. Two man-made conveyances were also noted on the property, but these were determined to be non-jurisdictional due to the lack of ordinary high water marks and the absence of flow. The adjacent, similarly situated, property to the north was determined to be uplands in 2007 (SAC 2007-881-2JM).
