Explain: An upland dug pond (0.69 acres) was noted in the center of the subject property. This feature was determined to be non-jurisdictional since it was excavated from uplands. An upland dug ditch was noted to the west and north. This feature is clearly man-made with existing spoil piles adjacent to the ditch. This feature apparently serves as an overflow ditch for an offsite impoundment to the immediate west. The feature is approximately 6 feet wide and 3 feet deep and 425 feet long. It was

dry at the time of the site visit and exhibits no ordinary high water mark, no evidence of recent flow and no hydrophytic vegetation in the bottom of the ditch. Accordingly, this man-made feature was determined to be non-jurisdictional.

**A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** No jurisdictional wetlands were found on the subject property. The NWI shows the area as uplands (U43). The Charleston County Soil Survey has the subject property mapped as St. John and Dawhoo both of which are hydric soils in Charleston County. This property was examined by a registered soil scientist (Fowler) in 2006, and determined to be uplands. Soil samples made at the site visit show soils displaying uncoated sand grains (salt & pepper) and therefore the subject property was determined to be uplands (see photo 2). Additionally, an upland dug pond was noted and determined to be non-jurisdictional as was an upland dug ditch across the center portion of the property.
