It is within the area recommended to be considered "navigable waters of the U.S. The Lynches River at this location is not subject to the ebb and flow of the tide.**

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": **Wetland flow is to the Lynches River (TNW). Wetland 1 and Wetland 2 directly abut the TNW. Wetland 1 flows across the west property line through the site, through a 36" CMP culvert, to continue off-site to the east onto adjacent property. The off-site wetlands continue to intercept the OHWM of the TNW. Wetland 2 flows across the west property line through the site, through a 36" CMP culvert, and intercept Wetland 1 off-site within 200' of the TNW. These wetlands appear, from aerial photographs, to be an "oxbow" wetland feature of the Lynches River. Dry season drainage features were noted within both Wetland 1 and Wetland 2 and have been described as pRPW#1 (on this form) and pRPW#2 (on Form 2 of 2).**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

be perennial due to the presence of the strong flow of water under drought influenced climatic conditions witnessed during multiple site visits and by identification of many indicators of perennial flow. The feature was man-altered and was approximately 3' deep by 3' wide and was entirely within Wetland 1. Stream geomorphic indicators of perennial flow were a well-defined channel which was deeper than the surrounding wetlands, constituting bed and banks (inundated at the time of the site visits) and presence of an OHWM (on vegetation in the vicinity of the channel). The bottom channel was approximately 3' wide at the bottom and strong flow was observed during the time of the site visit. Throughout the center of the channel a lack of vegetation was evident due to inundation to approximately 3' and the flow of water. Due to the presence and flow of water during a drought period, it has been determined that this feature intercepts ground water. Some riffle and pool complexes and formations were observed but were subtle due to the low gradient of the stream and the presence of inundation within the floodplain wetlands. This season's leaves and debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps do not depict this reach. Aerial photos show the presence of inundation of water and also show that the feature continues onto adjacent property where it turns to the north. This feature continues north entirely within wetlands directly adjacent to the Lynches River and becomes the property line for the subject property before intercepting the OHWM of the Lynches River (TNW).

B. **ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. A prevalence of hydrophytic vegetation, multiple hydrology indicators, and hydric soils were observed within the flagged wetland boundary which was verified. Wetlands flow is to the Lynches River (TNW). Wetland 1 and Wetland 2 directly abut the TNW. Wetland 1 flows across the west property line through the site, through a 36" CMP culvert, to continue off-site to the east onto adjacent property. The off-site wetlands continue to intercept the OHWM of the TNW. Wetland 2 flows across the west property line through the site, through a 36" CMP culvert, and intercept Wetland 1 off-site within 200' of the TNW. These wetlands appear, from aerial photographs, to be an "oxbow" wetland feature of the Lynches River. Dry season drainage features were noted within both Wetland 1 and Wetland 2 and have been described as pRPW#1 (on this form) and pRPW#2 (on Form 2 of 2). Flow of the on-site tributary, pRPW#1 (Unnamed Tributary of Lynches River) was determined to be perennial due to the presence of the strong flow of water under drought influenced climatic conditions witnessed during multiple site visits and by identification of many indicators of perennial flow. The feature was man-altered and was approximately 3' deep by 3' wide and was entirely within Wetland 1. Stream geomorphic indicators of perennial flow were a well-defined channel which was deeper than the surrounding wetlands, constituting bed and banks (inundated at the time of the site visits) and presence of an OHWM (on vegetation in the vicinity of the channel). The bottom channel was approximately 3' wide at the bottom and strong flow was observed during the time of the site visit. Throughout the center of the channel a lack of vegetation was evident due to inundation to approximately 3' and the flow of water. Due to the presence and flow of water during a drought period, it has been determined that this feature intercepts ground water. Some riffle and pool complexes and formations were observed but were subtle due to the low gradient of the stream and the presence of inundation within the floodplain wetlands. This season's leaves and debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps do not depict this reach. Aerial photos show the presence of inundation of water and also show that the feature continues onto adjacent property where it turns to the north. This feature continues north entirely within wetlands directly adjacent to the Lynches River and becomes the property line for the subject property before intercepting the OHWM of the Lynches River (TNW). Two man-made ponds were determined to be entirely dug in uplands. A soils investigation was completed on the downhill sides of each of the ponds and three parameters were not discovered. No additional features were observed during the investigation.**
