Explain: **Wetland A and Wetland B are 1.519 acre and 0.637 acre, respectively, isolated, non-jurisdictional palustrine, depressional wetlands. Wetland A is located at the northern end of the subject tract. Wetland B is located in the**

middle of the tract. Corps personnel and consultants approached both wetlands from the west and circled them. Both wetlands were at obviously lower elevations than the surrounding area. Wetland A was approximately 1500 feet and Wetland B was approximately 1000 feet from the nearest jurisdictional water to the south. There was no evidence of sheetflow leading away from the wetlands in any direction, no evidence of matted vegetation, or indication of any surface or subsurface connection to any other wetland or Water of the U.S. They are not connected to any navigable waters or any tributary to navigable water, or contiguous or adjacent to any surface tributary system, and are not interstate waters or connected to interstate water in any fashion. In addition, there is a non-jurisdictional linear conveyance (0.341 acre) on-site that extends from the northwest corner midway down the site to the western property boundary along Spaniel Lane. The conveyance is a shallow swale at the northern end, deepening in the middle to become a ditch, and becomes quite shallow - a broad swale - again on the western end where it intersects with Spaniel Lane. There is no ditch or linear conveyance that extends off-site. The topographic maps indicate that there is a blue line stream in the same general vicinity as this on-site conveyance. The blue line stream on the topo map continues off-site in a northly direction beyond the project site for approximately 1300 feet. However, just beyond the northern property boundary there is currently a large warehouse that extends the entire width (east / west) of the site. There is no evidence of a blue line stream on the ground. The on-site conveyance is neither a seasonal nor perennial RPW. Further, the on-site conveyance does not connect to any other wetland on-site and does not tie into any other Water of the U.S. off-site.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: One JD (2007-107) for Scana/Spaniel Lane was done for Parcel E (noted as Parcel E on plat) on the southern end of the tract. Another JD (2007-01916) was done for Batten and Moore, LLC/Spaniel Land (noted as Residual Tract on plat) at the northern end of the tract. The two parcels are contiguous but the JDs were done at different times by different project

managers. The Scana JD indicated that there were wetlands extending on the Batten and Moore JD, but that was not clearly depicted. Therefore, when SCANA purchased the Batten and Moore property, it requested that our office take another look at the properties as one JD and reconcile the difference. The current JD addresses the wetlands on both parcels, as one parcel now owned by SCE&G. Further, the new JD depicts a linear conveyance feature that is non-jurisdictional also; however, neither wetlands nor the linear conveyance are jurisdictional based on a site visit, aerial photos, quad sheets, and soils maps.
