Explain: **There is one non-jurisdictional isolated wetland that is located within the boundaries of Project Area 1. The wetland is 2.14 acres in size. No ditch, swale, or other linear feature was observed coming out of the wetland. There**

was also no evidence of a discrete hydrologic connection through the surrounding uplands to a water of the U.S. The non-jurisdictional isolated wetland has no surface connection and no apparent sub-surface connection to a water of the U.S. The wetland has no physical, biological, or hydrological connection to a water of the U.S. and has no apparent connection to interstate or foreign commerce. Non-Jurisdictional Wetland 1 is not subject to jurisdiction under the Clean Water Act. In addition to the wetland, there is a non-jurisdictional linear conveyance within the boundaries of Project Area 1. It appears as a blue line stream on topo maps; however, the feature does not cross Project Area 1 as indicated on the topo map and the feature is not a tributary. The feature is located at the "downstream" end near a dirt road and continues offsite. The feature is a swale and does not have a defined bed or bank, OHW, relatively permanent flow, does not provide a hydrologic connection from a wetland or water, and drains only uplands. The linear conveyance was determined to be non-jurisdictional under the Clean Water Act and is perhaps not even a water feature.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
