C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide data and rationale indicating that tributary is perennial: The RPW on the southwest end of the subject tract is approximately 20 feet wide and three feet deep. It appears to be somewhat manipulated as it flows in a relatively straight line with specific turns until it intersects with Church Creek. There was water flowing in the RPW during two different site visits conducted by two different project managers. The RPW originates offsite and northwest of Bees Ferry Road, flowing south where it turns to the southwest and runs parallel with Bees Ferry Road. The RPW then turns southeast and flows through two large RCPs under Bees Ferry Road on to the subject tract. It continues in a southeasterly direction, flowing off-site and turning to the east where it intercepts an existing wetland

system and blue line stream on the quad sheet. The RPW flows into Church Creek, another perinneeal RPW which flows into the Ashley River, a TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are 1.67 acres of jurisdictional wetlands and a 748.5' linear RPW on the 46.60 acre tract. The wetlands are contiguous with the RPW which flows to the southeast and intersects with an unnamed blue line stream on the quad sheet which flows to Church Creek and the Ashley River, a TNW. These waters were determined to be jurisdictional through multiple site visits by two project managers, and review of aerial photos, quad sheets, soil survey and NWI information.
