C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project contains 740 linear feet of tributary determined to be an RPW with perennial flow. The onsite tributary identified as RPW #2 flows on the eastern boundary of the project area and discharges into RPW#1 which is documented on basis from 1 of 2. RPW# 2 has been observed flowing under various climatic conditions over the last two years of 2010 and 2011; most recently March 8, 2012 where rainfall was about 15inches below normal. RPW#2 is a man-made tributary that connects offsite wetlands, located to the east of the project area, to RPW#1 which eventually flows into the TNW.

In addition to the tributary identified as RPW#2, the project area contains an additional 3,290 linear feet of tributary (RPW#1) and 26.49 acres of adjacent wetlands. These aquatic resources are documented on basis form 1 of 2.
