This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

A jurisdictional determination of the property located immediately west and adjacent to this site determined that the upstream portion of Two Mile Creek has perennial flow (SAC 2010-00275-4JE; letter dated October 25, 2010). Two Mile Creek flows east into Polk Swamp, a perennial RPW, which flows southeast into Jeffries Creek, a perennial RPW. Jeffries Creek flows into the Great Pee Dee River, a TNW.**

The aeriels and topographic map depict a tributary at the southern property boundary with abutting wetlands, and the NWIs and soil survey depict these two wetlands as palustrine forested wetlands (PF01C, PF01/2Fb, PF01Fb) and hydric soils (Wehadkee and Johnston). The site visit confirmed that Wetlands "A" and "I" are portions of a larger wetland system that abuts Two Mile Creek .**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of the aerials, topographic map, soil survey, NWIs and site visit, the perennial RPW named Two Mile Creek intersects the boundary of Wetlands "A" and "I" on site. The aerials and topographic map depict a tributary at the southern property boundary with abutting wetlands, and the NWIs and soil survey depict**

these two wetlands as palustrine forested wetlands (PF01C, PF01/2Fb, PF01Fb) and hydric soils (Wehadkee and Johnston). The site visit confirmed that Wetlands "A" and "I" are portions of a larger wetland system that abuts Two Mile Creek

The tributary on site depicted as "TWO MILE CREEK PRPW" on the plat was determined to have perennial flow based on a review of aeriels, topographic map, soil survey, NWIs, and a previous jurisdictional determination with a site visit. The aeriels depict a shaded linear feature indicative of a tributary, and the topo map shows this tributary as a solid blue line, which usually indicates perennial flow. The NWIs and soil survey depict wetlands and hydric soils surrounding this tributary. A jurisdictional determination of the property located immediately west and adjacent to this site determined that the upstream portion of Two Mile Creek has perennial flow (SAC 2010-00275-4JE; letter dated October 25, 2010). Two Mile Creek flows east into Polk Swamp, a perennial RPW, which flows southeast into Jeffries Creek, a perennial RPW. Jeffries Creek flows into the Great Pee Dee River, a TNW.
