C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

It then emerges in an open channelized stream before being piped again under the Naval Weapons Station housing before entering Foster Creek.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Jurisdictional wetlands on site are associated with an unnamed tributary to Fosters Creek (TNW). The segment of the unnamed tributary on site has been incorporated into a stormwater retention pond. As a result of the stormwater retention pond construction, the original stream bed has been obscured. From the subject property the unnamed tributary has been piped under North Rhett Extension and Red Bank Road as well as much of the developed area between the subject property and Fosters Creek. The original location of the unnamed tributary is visible on the USGS Quad map. Although man-made features have obscured the original tributary, these wetlands are still subject to the Clean Water Act .
