C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: The review area was defined as the OHWM for a man-made body of water. A review of aerial photography determined that the area had been forested as recent as 1994 and by 1999, the review area had been clear cut and a pond had been excavated for recreational purposes as a portion of a golf course. A review of soil surveys indicated that the entire area was mapped as Pantego, a hydric soil. In addition, the NWI maps identify the entire review area as PSS4/1Bd, wetlands. According to the NWI maps, the polygon of this wetland system continues outside of the review area to the north, northwest, northeast, and east and is adjacent and abutting the perennial RPW, Shot Pouch Creek. An off-site investigation of this wetland system in the areas to the north, northwest, northeast, and east was conducted on September 9, 2008 and wetlands were identified in file number SAC-2007-00524-4JB Black River Airport Industrial Park as being jurisdictional with a downstream connection to the Black River via Shot Pouch Creek, a perennial RPW. Three (3) wetlands were identified on Form 2 of 6 and are described as follows: "The three wetlands are part of a larger wetland system that extends offsite. The wetlands would connect to the RPW via continuous surface connections, however, a golf course pond has been excavated out of the wetland system and the spoil has been sidecasted back into the wetland, breaking the connection to the tributary (perennial RPW)." Due to the circumstances, these wetlands and the off-site impoundment were considered to have a continuous surface connection

to Shot Pouch Creek. Based on all of this information, it has been determined that Impoundment 1 is a water of the United States. The impoundment is approximately 7.27 acres and is at least partially excavated out of jurisdictional wetland waters of the United States, which are described in the above-referenced file.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area was defined as the OHWM for a man-made body of water. A review of aerial photography determined that the area had been forested as recent as 1994 and by 1999, the review area had been clear cut and a pond had been excavated for recreational purposes as a portion of a golf course. A review of soil surveys indicated that the entire area was mapped as Pantego, a hydric soil. In addition, the NWI maps identify the entire review area as PSS4/1Bd, wetlands. According to the NWI maps, the polygon of this wetland system continues outside of the review area to the north, northwest, northeast, and east and is adjacent and abutting the perennial RPW, Shot Pouch Creek. An off-site investigation of this wetland system in the areas to the north, northwest, northeast, and east was conducted on September 9, 2008 and wetlands were identified in file number SAC-2007-00524-4JB Black River Airport Industrial Park as being jurisdictional with a downstream connection to the Black River via Shot Pouch Creek, a perennial RPW. Three (3) wetlands were identified on Form 2 of 6 and are described as follows: "The three wetlands are part of a larger wetland system that extends offsite. The wetlands would connect to the RPW via continuous surface connections, however, a golf course pond has been excavated out of the wetland system and the spoil has been sidecasted back into the wetland, breaking the connection to the tributary (perennial RPW)." Due to the circumstances, these wetlands and the off-site impoundment were considered to have a continuous surface connection to Shot Pouch Creek. Based on all of this information, it has been determined that Impoundment 1 is a water of the United States. The impoundment is approximately 7.27 acres and is at least partially excavated out of jurisdictional wetland waters of the United States, which are described in the above-referenced file..
