## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). **B.** ADDITIONAL COMMENTS TO SUPPORT JD: The 3.760 acre property consists of 0.496 acres of tidal wetlands that are regulated by Section 10 of the RHA and Section 404 of the CWA. A review of the wetland data sheets, aerial photos, and soil survey information indicate that the remainder of the property consists of uplands. In the aerial photo, a darker signature appears through the property. This signature consists of a grassy and sandy area that is very slightly lower than the surrounding land. This area is

shown in photographs provided by the consultant that are in the project file. This area is not considered a swale or other linear conveyance feature.
