C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

an onsite man-made pond (excavated within a wetland). A portion of the tributary along the northwest property boundary is impounded as a result of beaver activity. However, the portion of the tributary that is not impounded or flowing through the pond, exhibits characteristics of a perennial RPW. It is depicted as a dotted blue line on topographic maps. Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks, had a firm sandy bottom, OHWM (line impressed on the bank), clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream. Flowing water and recent beaver activity was observed during the site visit .

B. ADDITIONAL COMMENTS TO SUPPORT JD: This is a 1.6 acre site consisting of 2 wetlands, impoundment of jurisdictional waters, and a perennial RPW. The two wetlands (W1 and WA) total 0.952 acres and directly abut the on-site perennial RPW. Recent beaver activity has occurred on-site which has impounded a portion of the RPW. A pond was also excavated within the wetland and RPW resulting in an impoundment.
