Explain: **There is one depressional wetland at the northern boundary of the subject property. This feature is approximately 3.75 acres in size and is approximately one foot below the surrounding uplands. The closest jurisdictional wetland is approximately 1,100 feet from this feature and there are no ditches connecting this feature to another wetland. There is no surface or apparent subsurface hydrologic connection to the jurisdictional wetlands, no**

apparent chemical connection, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce. Three roadside swales were also noted totaling 3,600 feet in length, four feet wide and three feet deep. These swales were dug from uplands and show no flow or ordinary high water mark, and were determined to be non-jurisdictional.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There is one isolated wetland on the subject property. This isolated wetland measures 3.75 acres in size, about one foot in depth below the surrounding uplands and 1,100 feet from the nearest jurisdictional wetland.

This isolated area has been checked carefully in the field to make sure there are no connections to jurisdictional systems. There is no surface or apparent subsurface hydrologic connection between the jurisdictional wetlands and the isolated features. Accordingly there is no visible chemical connection with jurisdictional wetlands, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce.
