Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: An approximate 1.5-acre area central in the site was excavated about 1.5-2 feet deep several years ago. The material was not stockpiled on the tract. This area shows uneven, sharp-banked work area edges that avoided mechanically-clearing large diameter hardwoods (oaks, magnolias) and left standing on upland terraces throughout. The soil color within the upper strata of the work area (4/2) is consistent with soil color of uplands elsewhere on the tract at that depth. Southern Magnolias are recruiting in the excavated area, typical of this species in disturbed uplands. No compelling hydrological indicators are evident in the excavated area. This area, and the site as a whole, does not contain wetlands, dug conveyances or other "waters of the US" subject to federal jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is a 7.14-acre tract of hardwood-pine forest that has had the front 250' cleared and developed as a community center facility and parking lot. On inspection, the whole site (NWI-listed as 'uplands') were characterized by showing no listed hydrological criteria, high chroma soils (4/3-4 in the surface horizons) and FAC-to-FAC+ rated dominant vegetation. While NRCS-listed as hydric, the mapped *Stono* soils of this site showed higher-than-2 chroma colors and a high (>30%) uncoated grain composition throughout the area.

An approximate 1.5-acre area central in the site was excavated about 1.5-2 feet deep several years ago. The material was not stockpiled on the tract. This area shows uneven, sharp-banked work area edges that avoided mechanically-clearing large diameter hardwoods (oaks, magnolias) and left standing on upland terraces throughout. The soil color within the upper strata of the work area (4/2) is consistent with soil color of uplands elsewhere on the tract at that depth. Southern Magnolias are recruiting in the excavated area, typical of this species in disturbed uplands. No compelling hydrological indicators are evident in the excavated area.
