Explain: Wetland A and Wetland B are 0.65 acre and 0.80 acre, respectively, isolated, non-jurisdictional palustrine, depressionnal wetlands. Wetland A is located at the west end of the subject tract in the center of a topographically elevated, non-forested power line trail that runs east to west. Wetland B is located in the middle of the subject tract within a deciduous forest.

Corps personnel circled both of the wetlands. Wetland A is contained within a sharp topographic convex pool approximately one foot deep that marks the boundary of the wetland from its upland surroundings and keeps the water within Wetland A from flowing out. There was no evidence of matted down, bent, or absent vegetation, no sightings of water staining, sediment deposit coatings, nor other evidence of any existing drainage pattern or surface flow of water between Wetland A and the linear conveyance feature that would create a hydrological connection between the two.

The boundary line of Wetland B is contained within a moderate topographic convex pool that helps keep water within the Wetland B interior. Similar to Wetland A, Wetland B shows no evidence of matted down, bent, or absent vegetation, no evidence of water staining, sediment deposit coatings, nor evidence of any existing drainage pattern or surface flow of water between the Wetland and the linear conveyance feature. Unlike Wetland A, Wetland B is in a deciduous forest, so you can make out the flow of the water-stained leaves hydrology indicator ends from within the wetland, making the distinction clearer that surface water does not flow from Wetland B into the linear conveyance feature.

Both Wetlands are completely surrounded by uplands that possess upland soil and no hydrology indicators. These wetlands are not connected to any navigable waters or any tributary to navigable water, or contiguous or adjacent to any surface tributary system or connected to interstate waters in any fashion.

The non-jurisdictional linear conveyance feature (approximately 2500 linear feet within the confines of the subject property) originates within uplands, is excavated from uplands, and drains only uplands. This feature originates from the east upland portion of the subject property and serves as a drainage feature for the clear-cut power line trail as the feature follows the power line trail alongside its south slope westward and splits into two directions towards the center of the property. The southward branch of the linear conveyance feature drains an upland deciduous forest and a residential area. It extends slightly further off the property, crossing a culverted road where it ends as a gradual swale that connects to a system of roadside ditches. The westward branch drains the same residential community, as well as continuing to drain the upland power line trail. This westward branch continues further off the property till the linear conveyance feature ends at a pond.

Within the confines of the property boundary, the bank of the linear conveyance feature is cut deep compared to its immediate surroundings (approximately 15 feet in depth) and possesses a sharp, steep slope. The bed of the linear conveyance feature shows evidence of containing water, but no evidence of it flowing. It contained patches of pooled water throughout, large piles of water-stained leaves, no vegetation, and a large amount of human garbage. The sharp slope of the ditch is approximately 30 feet from Wetland A and approximately 90 feet from Wetland B and the bed of the linear conveyance feature is approximately 14 feet below the elevation of Wetlands A and B. The topographic maps do not show this linear conveyance feature on the maps as a blue line or natural stream. The maps do show the power line trail running from east to west that the linear conveyance features follows, indicating that the feature was man-made with the intent of draining uplands. This linear conveyance feature is neither a seasonal nor perennial RPW. It's is a linear conveyance feature that originates in uplands, drains only uplands, and is not considered a Water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
