This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a period of normal climatic conditions, however, rainfall data recorded over the previous year suggests that the site visit was conducted during a drought year. At multiple locations, soils were determined to be non-hydric. Hydrology and hydrophytic vegetation indicators were noted in the southeast corner of the site, but hydric soils were not present. A linear feature was observed on aerial infrared photographs. The feature is not mapped on USGS Quad Maps. The feature was observed to be man-made and to have bed and banks and an OHWM. The feature was determined to be a non-jurisdictional ditch as it was excavated out of uplands and drains only uplands. No other potentially jurisdictional features were observed within the review area.
