B. ADDITIONAL COMMENTS TO SUPPORT JD: No wetlands or Waters of the US were observed during a site audit or after a review of available resources in the office. The site is a undeveloped forested area surrounded by residential dwellings. Horry County Soil Survey information depicts the site as comprised Leon soils which are considered hydric, however no hydrology was observed during field observation (soil samples taken during the site visit revealed high chroma soils). Horry NWI data depicts the site as U42P, an upland symbol. USGS topographic maps (Brookgreen Quad) depict a forested upland site. No other ditches, tributaries, or other potential Waters of the US are found onsite. This site is located approximately 5000 linear feet from the nearest jurisdictional feature (Collins Creek).
