Explain: **There exists an approximate 0.05 acre non-jurisdictional ditch on-site that originates at the southeast edge of the property and extends to the west edge of the property site. This ditch extends approximately 780 linear feet further west off the property site, where it drains into the City of Summerville's sewer system. This ditch is neither a seasonal nor perennial RPW. It does not contain evidence of shelving, or a clear natural line impressed upon its bank, or other**

indicators that identifies an ordinary high water mark. In addition, this ditch contained no flowing water or evidence of flowing water. The location of this ditch does not appear as a blue line stream on topographic maps and does not appear to be a natural stream. This ditch is draining only uplands and originates within uplands, and does not fall within Federal Clean Water Act jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This JD form documents the jurisdictional status of a 0.88 acre tract located within Gahagan Park, adjacent to Owens Drive and West Boundary Street, Charleston County, South Carolina. The tract consists of a maintained grassy lawn, an upland deciduous forest, and an approximate 0.05 non-jurisdictional ditch. Based on an on-site inspection and a review of aerial

photography and soil survey information, it has been determined that the referenced property does not contain any wetland areas or other waters of the United States and, as such, does not fall under Federal Clean Water Act jurisdiction.
