Explain: **A 0.06-acre depression located central on the site has been dug or scraped to a depth of about 12-14" from the surrounding upland land position. On the lot boundary immediately west of the subject lot, several prominent berms have been constructed in concentric arcs approximately 4-5 feet tall and 5' wide made of material obviously derived from the adjacent scraped depression. Trees of 8-10" DBH are rooted in the berms indicating the work is several decades old.**

Soil sampling of the area shows a high chroma profile ( 3/3-4), quite friable, consistent with (upland) borings elsewhere on the site at similar depths. The depression area supports Southern Magnolias and mature Spruce Pines, a few Red Maples and a sparse Wax Myrtle shrub layer. The maples in the depression showed weakly-buttressed bases but no listed hydrological indicators are evident despite its depression profile. The area is not a 'waters of the U.S.' subject to federal jurisdiction.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: **The site is a 0.631-acre residential building lot ('Lot 97') in a developed subdivision ('Plantation at Stono Ferry'). A 0.06-acre depression is located central on the site and has been dug or scraped to a depth of about 12-14" from the surrounding upland land position. On the lot boundary immediately west of the subject lot, several prominent earthen berms have been constructed in concentric arcs, approximately 4-5 feet tall and 5' wide, and made of material obviously derived from the adjacent scraped depression. Trees of 8-10" DBH are rooted in the berms indicating the work is several decades old. The landforms resemble small Civil War-style earthworks but consultation with staff of the SC State Historic Preservation Office showed no record of any Sec106 cultural resources were on or near the site.**

**Soil sampling of the area shows a high chroma profile (3/3-4), quite friable, consistent with (upland) borings elsewhere on the site at similar depths. The depression area supports Southern Magnolias and mature Spruce Pines, a few Red Maples and a sparse Wax Myrtle shrub layer. The maples showed very weakly-buttressed bases but no listed hydrological indicators are evident despite its depression profile. The lot borders tidal marshes of the Stono River but the surveyed property boundary is set at the upland/Sec10 boundary. No freshwater wetlands extend from the tidal waters into the site.**

**'Lot 97' has no wetland areas, no 'waters of the US', subject to federal jurisdiction.**
