C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The site is a 1.001-acre tract of previously-cleared upland hardwood forest, developed as a residential building site. A Jurisdiction Determination was requested to fulfill Charleston County subdivision policy. The remnant forest canopy on the property boundary was dominated by Live Oaks and Sweet Gums, over non-hydric but low-chroma soils with a high (<30%) uncoated grain content. No evidence of listed surface hydrological indicators was present. The site does not hold wetlands, dug-conveyances or other resources subject to federal Clean Water Act jurisdiction.
