- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four isolated wetlands were assessed within the review area totaling 13.7 acres. These four wetlands were determined to be isolated based on a review of the topographic map, soil survey, and NWIs, and a site visit. Each of the wetlands' boundaries were verified during the site visit on April 20, 2011, and were determined to be isolated due**

to a hydrologic separation from other waters of the US. The topographic map depicts this area as a wetland bay with no tributaries or other features near the boundary of the bay. The soil survey maps this bay as a hydric soil (Rembert) completely surrounded by non-hydric soils (Troup and Lucy). The aerials depict these wetlands as palustrine wetlands (PUBHx, PEM1Cd, PEM1Ad) that are surrounded by uplands (U21 and U12). This site has several Corps files associated with it including approximately six Nationwide 26 permits for fill or other impacts. A railroad track crosses the northern portion of this historic bay, and no culvert could be located under the railroad tracks. Additionally, during the site visit, each wetland boundary was walked and no linear features or other Waters of the US were located at or near the boundary of these four wetlands. A culvert was observed located at the southern end of Wetland "A" which was determined to connect to Wetland "C". Indicators of water flowing into Wetland "A" from Wetland "C" were observed such as sediment deposits and wrack lines. Additionally, a culvert was observed connecting Wetland "C" to Wetland "D"; however, no other outlets were located for Wetland "D". All of the isolated wetland boundaries were verified during the site visit on April 20, 2011, and were found to be completely surrounded by non-hydric soils with no surface or subsurface connection to other waters of the US. These wetlands retain water within the wetland boundary and have no evidence of a chemical or biological connection to other waters of the US; therefore, Wetlands "A", "B", "C", and "D" were determined to be non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These four wetlands were determined to be isolated based on a review of the topographic map, soil survey, and NWIs, and a site visit. Each of the wetlands' boundaries were verified during the site visit on April 20, 2011, and were determined to be isolated due to a hydrologic separation from other waters of the US. The topographic map depicts this area as a wetland bay with no tributaries or other features near the boundary of the bay. The soil survey maps this bay as a hydric soil (Rembert) completely surrounded by non-hydric soils (Troup and Lucy). The aerials depict these wetlands as palustrine wetlands (PUBHx, PEM1Cd, PEM1Ad) that are surrounded by uplands (U21 and U12). This site has several Corps files associated with it including approximately six Nationwide 26 permits for fill or other impacts. A railroad track crosses the northern portion of this historic bay, and no culvert could be located under the railroad tracks. Additionally, during the site visit, each wetland boundary was walked and no linear features or other Waters of the US were located at or near the boundary of these four wetlands. A culvert was observed located at the southern end of Wetland "A" which was determined to connect to Wetland "C". Indicators of water flowing into Wetland "A" from Wetland "C" were observed such as sediment deposits and wrack lines. Additionally, a culvert was observed connecting Wetland "C" to Wetland "D"; however, no other outlets were located for Wetland "D". All of the isolated wetland boundaries were verified during the site visit on April 20, 2011, and were found to be completely surrounded by non-hydric soils with no surface or subsurface connection to other waters of the US. These wetlands retain water within the wetland boundary and have no evidence of a chemical or biological connection to other waters of the US; therefore, Wetlands "A", "B", "C", and "D" were determined to be non-jurisdictional .
