This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

4. **Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs:** The tributary (seasonal RPW; unnamed tributary to Susybole Creek) enhances a variety of wildlife species by providing diversity through vegetation and substrate changes where aquatic systems adjoin uplands. Due to surrounding land use, the tributary transports water, sediment, and other pollutants from adjacent uplands to the TNW. The tributary transfers nutrients and organic carbon that support downstream foodwebs. Monitoring performed by the South Carolina Department of Health and Environmental Control (SCDHEC) on Turkey Creek indicates that recreational uses are not supported due to high fecal coliform bacteria, but that aquatic life uses are partially supported based on macroinvertebrate data. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of Turkey Creek, this office has determined that there is a Significant Nexus between the review area relevant reach (seasonal RPW; unnamed tributary to Susybole Creek) and the downstream TNW.

A review of the sources referenced in Section IV. A. also indicates that this tributary flows seasonally under normal circumstances. The tributary is depicted as an intermittent stream on the USDA NRCS soil survey and on the USGS topographic map. The tributary has approximately 159 acres of drainage area.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This JD is for an approximately 14 acre portion of a 265.85 acre tract. The only water of the U.S. within the 14 acre review area is a seasonal RPW (unnamed tributary to Susyhole Creek). Seasonal RPWs are jurisdictional according to RGL 07-01; however, Significant Nexus findings for the record are included for this tributary, as required by Rapanos Guidance.
