C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

"Jurisdictional Perennial RPW" on the plat flows year-round. The aerials depict this tributary as a shaded linear feature, and the topographic map depicts a solid blue line that originates northeast of the project site and continues west off site. The site visit confirmed that this tributary has perennial flow based on the presence of iron-oxidizing bacteria within the streambed and soils saturated at the surface on site. This tributary originates on the southern portion of the property within the on-site wetlands and continues flowing west off site. The tributary was also viewed off site immediately upstream of its crossing with the railroad tracks and further downstream at its intersection with Day Street, immediately prior to where it intersects with another tributary and flowing water was observed at both locations. This tributary is named Pye Branch and continues south where it flows into Jeffries Creek, a perennial RPW that flows directly into the Great Pee Dee River..

B. The topographic map depicts a solid blue line intersecting the length of the wetland on site; however, during the site visit this tributary was observed originating near the southwestern corner of the wetland on site. At this location, a headcut was observed and iron-oxidizing bacteria was observed in the upstream portion of the channel within the boundary of the wetland. This wetland is depicted as palustrine forested (PF01Bd) on the NWI and as Coxville, a hydric soil, on the soil survey. The aerials depict the tributary as a shaded linear feature, and the topographic map depicts a solid blue line that originates northeast of the project site and continues west off site. The site visit confirmed that this tributary has perennial flow based on the presence of iron-oxidizing bacteria within the streambed and soils saturated at the surface on site. This tributary originates on the southern portion of the property within the on-site wetlands and continues flowing west off site. The tributary was also viewed off site immediately upstream of its crossing with the railroad tracks and further downstream at its intersection with Day Street, immediately prior to where it intersects with another tributary and flowing water was observed at both locations. This tributary is named Pye Branch and continues south where it flows into Jeffries Creek, a perennial RPW that flows directly into the Great Pee Dee River..
