the USGS Topo Map as a dashed blue line, indicating intermittent flow. During the field visit, both of these features were determined to have been excavated in uplands and draining only uplands. No surface flow was witnessed within the bottom channel at the time of the site visit which was during an extended period of drought. These two features were determined to be non-jurisdictional ditches. No other potentially jurisdictional features were observed within the review area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a drought year according to local rainfall data. At multiple locations, soils were determined to be non-hydric. At a low point on the site which best represented the transition between off-site wetlands and on-site uplands, soils were determined to be non-hydric and no hydrology indicators were encountered. A prevalence of hydrophytic vegetation was not encountered. No wetlands were discovered on the subject property. Two linear features were observed on the subject site. Both of these features are evident on aerial photographs as man-made linear features potentially for drainage of adjacent agricultural fields. One of the features is shown on the USGS Topo Map as an dashed blue line, indicating intermittent flow. During the field visit, both of these features were determined to have been excavated in uplands and draining only uplands. No surface flow was witnessed within the bottom channel at the time of the site visit which was during an extended period of drought. These two features were determined to be non-jurisdictional ditches. No other potentially jurisdictional features were observed within the review area.
