**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide rationale indicating that wetland is directly abutting an RPW: **The wetlands (Wetland 1) onsite are part of a larger wetland complex that continues offsite and is intersected by the OHWM of McCalls Branch, a perennial RPW. The presence of the perennial RPW was identified on aerial photographs as being due east of the subject property and is featured as a solid blue line on USGS topographic maps. The tributary was observed downstream of the subject property and did exhibit a natural channel within floodplain wetlands with a width of approximately 15' with presence of sand and cobble on the channel bottom which had been subjected to sediment sorting. Riffle/pool complexes were documented. The tributary was observed during a period of extreme drought and surface flow was not observed. Due to the drought conditions and the presence of many surface indicators, it was determined that despite the absence of surface water, this tributary is perennial, flowing at least 90% of the year under normal climatic conditions. The perennial RPW demonstrated clearly defined channel with bed and banks, identification of an OHWM included leaf litter disturbed or washed away, sediment deposition, the presence of a wrack line, sediment sorting and scouring. The wetland system, which the area in review is a part of, is adjacent and abutting McCalls Branch, a perennial RPW which flows into Sparrow Swamp, a perennial RPW, which flows into Lake Swamp, a perennial RPW, which flows into Lynch River, a TNW.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries for Wetland 1 was established using the 1987 Wetland Delineation Manual. The subject site is mapped with Noboco, Rains, and Coxville (hydric) soils. A majority of the site is depicted on the NWI maps as U21, uplands. A portion of the site on the south and east property boundaries is mapped as PFO4Bd and PFO1/4Bd, wetlands. The site consists of upland areas, recently clear-cut of timber, sloping downhill towards a jurisdictional wetland system which continues off property. The wetland system directly abutting the stream displayed strong signs of hydrology, including water-stained leaves, oxidized rhizospheres on living roots, geomorphic positioning, and FAC-neutral test. Also, 100% hydrophytic vegetation was present within the wetland area. Soils were described as having a depleted matrix with chroma of 2 or less in the upper 12 inches. A linear feature was evaluated along the north property line and no OHWM was observed. The feature was determined to be a non-jurisdictional ditch. No other ditches or other aquatic features were discovered intercepting the wetland system from the subject property. The wetlands (Wetland 1) onsite are part of a larger wetland complex that continues offsite and is intersected by the OHWM of McCalls Branch, a perennial RPW. The presence of the perennial RPW was identified on aerial photographs as being due east of the subject property and is featured as a solid blue line on USGS topographic maps. The tributary was observed downstream of the subject property and did exhibit a natural channel within floodplain wetlands with a width of approximately 15' with presence of sand and cobble on the channel bottom which had been subjected to sediment sorting. Riffle/pool complexes were documented. The tributary was observed during a period of extreme drought and surface flow was not observed. Due to the drought conditions and the presence of many surface indicators, it was determined that despite the absence of surface water, this tributary is perennial, flowing at least 90% of the year under normal climatic conditions. The perennial RPW demonstrated clearly defined channel with bed and banks, identification of an OHWM included leaf litter disturbed or washed away, sediment deposition, the presence of a wrack line, sediment sorting and scouring. The wetland system, which the area in review is a part of, is adjacent and abutting McCalls Branch, a perennial RPW which flows into Sparrow Swamp, a perennial RPW, which flows into Lake Swamp, a perennial RPW, which flows into Lynches River, a TNW.**
