C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A site visit on October 11, 2011 was conducted to determine status of Chandler Bridge Creek. It is a large canal approximately 25 feet at the top of the berm and at least 10 feet across the bed. Flowing water was observed during the site visit. This is a large canal that provides storm water drainage for a portion of Town of Summerville.

The wetland is separated from Chandler Bridge Creek by a manmade berm (a walking path) constructed (possibly) of sediment excavated out of Chandler Bridge Creek. Based on topo maps, it appears that topography on both sides of the Creek slopes towards the Creek, so it is expected that subsurface flow continues to move from the wetland to Chandler Bridge Creek even though above ground sheet flow would be hindered by the walking path. In addition, the soils on both sides of Chandler Bridge Creek are listed as Mouzon which is a hydric soil.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: It is the determination of this office that the 3.702 acre wetland and the 524 linear feet (0.292 acre) area of Chandler Bridge Creek are jurisdictional as the wetlands connect with and abut Chandler Bridge Creek, and the Creek is an perennial RPW that flows to Eagle Creek, and RPW, that flows to the Ashley River, a TNW. This determination was made through on-site visits and the use and review of availabale information such as: aerial photos, USGS quad sheets/topo maps, USDA soil survey data, National Wetland Inventory data, and Google Earth satallite photos.
