C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

to be perennial due to the presence of the flow of water outside of the wet season under drought conditions and by identification of many indicators of perennial flow. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. Live submerged aquatic vegetation and other aquatic vegetation was observed growing within the bottom channel, which was approximately 6' wide at the bottom. Throughout the center of the channel a lack of vegetation was evident due to the flow of water. Also, in the center of the channel, a consolidated sandy bottom was discovered near the surface of the soil. No leaves or debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps depict this reach as a blue line stream named "Canal Branch" and aerial photos clearly show a stream along the northern property boundary. Flow continues in a due east direction until it enters Polk Swamp Canal. One onsite seasonal RPW (sRPW#1) was observed with a hydrologic connection to this feature and is described on form 2 of 2. Canal Branch and its floodplain wetlands continue east and flow into Polk Swamp Canal (perennial RPW), which continues south and flows into Jeffries Creek (perennial RPW) which continues in an east-southeast direction, providing a hydrologic connection to the Great Pee Dee River (TNW).

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a period of drought conditions. The prevalence of hydrophytic vegetation, hydric soils, and hydrology indicators including oxidized rhizospheres on live root channels were documented as evidence of the presence of wetlands on the subject property. Flow of the on-site tributary described on the sketch as pRPW#1 (Canal Branch) was determined to be perennial due to the presence of the flow of water outside of the wet season under drought conditions and by identification of many indicators of perennial flow. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. Live submerged aquatic vegetation and other aquatic vegetation was observed growing within the bottom channel, which was approximately 6' wide at the bottom. Throughout the center of the channel a lack of vegetation was evident due to the flow of water. Also, in the center of the channel, a consolidated sandy bottom was discovered near the surface of the soil. No leaves or debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps depict this reach as a blue line stream named "Canal Branch" and aerial photos clearly show a stream along the northern property boundary. Flow continues in a due east direction until it enters Polk Swamp Canal. One onsite seasonal RPW (sRPW#1) was observed with a hydrologic connection to this feature and is described on form 2 of 2. Canal Branch and its floodplain wetlands continue east and flow into Polk Swamp Canal (perennial RPW), which continues south and flows into Jeffries Creek (perennial RPW) which continues in an east-southeast direction, providing a hydrologic connection to the Great Pee Dee River (TNW). No other potentially jurisdictional features were observed on the subject property.
