Wetland B is a 3.39 acre wetland of which 2.62 acres are on the 24.17 acre parcel A owned by LeCreuset of America, 0.62 acres are located on the 1.35 acre parcel B owned by Hampton County, and 0.15 acres are located on an adjacent tract owned by the estate of William Sinclair. Wetland C is a 0.06 acre wetland of which 0.04 acres are on the 24.17 acre parcel owned by

LeCreuset of America and 0.02 acres are located on a 8.94 acre parcel C owned by Hampton County. The boundaries of these two wetlands, B and C, are completely surrounded by uplands and no conveyences were observed that would connect these wetlands to other wetlands or to waters of the U.S. There is no evidence of any physical, chemical or biological connections between either of these two wetlands and any waters of the U.S. There is no apparent subsurface hydrologic connection to interstate waters therefore, these wetlands are not subject to Section 404 regulations.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: In a previous JD (SAC 81-2005-0816), wetland B was described as a large forested wetland that drains west and southwest into offsite wetland areas. This wetland was comprised of a mixture of mature to mid-stage trees, and a portion that is located behind the LeCreuset facility is planted pines. At the time of the site visit, March 25, 2005, soils were saturated and inundation was observed in the central portion of the wetland. At the time of the site visits made for this current determination, additional land was accessable that allowed for wetland B to be completely observed. Wetland B is a forested depressional non-jurisdictional wetland surrounded by uplands. The one drainage feature connected to Wetland B that was observed in the field was a small linear conveyance that made a sharp right angle turn and came to an end at the base of a mature pine tree near the property line between parcel B owned by Hampton County and the Estate of William Sinclair. This feature was shallow and did not contain any indications of hydrology such as an ordinary high water mark or water stained leaves.

Wetland C was described as a small emergent wetland that appeared isolated containing mainly herbaceous vegetation and saturated soils at the time of the site visit in 2005. In 2011, this 0.06 acre wetland is described as isolated, non-jurisdictional located among pine stands but containing only herbaceous vegetation. There is no surface outlet or other hydrologic connection to a jurisdictional feature.

The remaining wetlands, A, D, E and F shown on the attachments are jurisdictional and are discussed on form 2 of 2.
