**B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: A 0.15 acre portion of Wetland A is located on Parcel A and all of Wetlands E & F are entirely located on Parcel A owned by LeCreuset, which is located along Bob Gifford Boulevard. These three wetlands are directly connected to a roadside swale that carries the flow to an unnamed tributary (RPW) that flows into the Coosawhatchie River. These wetlands provides a place for pollution from highway runoff to be filtered and diluted instead of directly discharging into the downstream waters. Wetlands A, E and F also provides stormwater storage and sediment filtration which are important wetland functions. Storm water can be temporarily stored and slowly released into the system thereby minimizing potential downstream flooding. All of these functions benefit the tributary (RPW) and the TNW downstream .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

All of these functions benefit the tributary (RPW) and the TNW downstream by lowering the flooding potential and decreasing the sediment load in the blackwater river system.

These wetlands are located in Watershed 03050208-07 which is located in Hampton and Jasper Counties and consists primarily of the Coosawhatchie River and its tributaries from Black Creek to its confluence with the Pocotaligo River to form the Broad River. The watershed occupies 139,753 acres of the Lower Coastal Plain and Coastal Zone regions of South Carolina. Land use/land cover in the watershed includes: 46.0% forested land, 24.3% forested wetland, 18.4% agricultural land, 4.6% barren land, 3.2% nonforested wetland, 2.0% urban land, and 1.5% water.

The Broad River flows into Port Royal Sound before reaching the Atlantic Ocean. The section of the TNW associated with this wetland, however, is upstream and is a blackwater system with low pH and low dissolved oxygen conditions.

Soils were saturated and inundation was observed within a portions of the wetlands located on the property. Some of the portion of Wetland A located across the property line was observable from the highway and across the property line at that time.
