of this wetland was observed in the field. The wetland is completely surrounded by non-hydric soils and no surface or shallow subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connections, the wetland (W-5) was determined to be isolated non-jurisdictional with no connection to any other waters of the U.S. Topographic maps do not depict a symbol which typically represents wetlands. No linear features (i.e. blue lines) are depicted on the topographic maps within close proximity of Wetland 5. .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland # 5 was determined to be isolated (non-jurisdictional). The entire perimeter of the wetland was observed on the site visit of June 20, 2011. Wetland # 5 is completely surrounded by non-hydric soils and no surface or shallow subsurface connections to water of the United States was observed during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfalls, topography grades, and lack of evidence of chemical or biological connections, the wetland was determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict do not depict a symbol which typically represents wetlands and does not depict a linear feature (i.e. blue line) in close proximity of the wetland (W-5).

In addition, the project area contains Wetlands 1, 2, 3, 4, 6, 7, &8 which are jurisdictional wetlands. The jurisdictional determination for these Wetlands is documented on basis forms 2 of 3 and 3 of 3.
