C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 6 has been determined to be adjacent; non-abutting an offsite tributary located the east of the project area and Farrow Parkway. The offsite tributary was determined to be a waters of the U.S. and documented in SAC # 2007-02249-3JH. Wetland 6 has a direct hydrologic connection to the tributary via an onsite swale that discharges into a roadside, stormwater ditch that discharges into an impoundment of water of the U.S. that outfall into un-named tributary of the AIWW. Wetland 6 (W-6) has been previously evaluated as adjacent wetlands to an offsite tributary where a positive significant nexus evaluation has been performed for tributary and similarly situated wetlands that included both abutting and non-abutting wetlands. The positive significant nexus determination that included the onsite wetland (W-6) has been documented in SAC 2008-00070-3JH, letter dated September 30, 2008.

The isolated, non-jurisdictional wetland (W-5) is documented on basis form 1 of 3. The remaining jurisdictional wetlands (W1, 2, 3, 4, 7, & 8) and tributary are documented on basis form 3 of 3.
