western linear feature originates within uplands halfway between the southwestern property corner and the northwestern property corner. This feature had water present during the site visit and an OHWM; however, leaf litter and debris were observed in the ditch. Neither of the linear features are depicted on the aerials or topographic map, and the NWI maps this entire site as uplands (U11). The soil survey maps this site as Duplin and Blanton, neither of which are listed as hydric soils. Both of these linear features were determined to be excavated out of uplands and drain uplands. Therefore, the two linear features were determined to be non-jurisdictional ditches..

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Two potentially jurisdictional linear features were assessed within the review area. These two linear features are located near the northwestern property corner. The northern feature was observed during the site visit to have dry leaf litter and debris in the bottom with no OHWM. This feature is approximately 2' wide and 6-8" deep. The**

western linear feature originates within uplands halfway between the southwestern property corner and the northwestern property corner. This feature had water present during the site visit and an OHWM; however, leaf litter and debris were observed in the ditch. Neither of the linear features are depicted on the aerials or topographic map, and the NWI maps this entire site as uplands (U11). The soil survey maps this site as Duplin and Blanton, neither of which are listed as hydric soils. Both of these linear features were determined to be excavated out of uplands and drain uplands. Therefore, the two linear features were determined to be non-jurisdictional ditches.

The southern portion of this site was previously developed and consists of an office building and paved parking lot. The northern portion of this property contains scrub-shrub vegetation. The entire site was determined to consist of uplands with no wetlands or other waters of the US present.
