C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area contains two tracts; Tract A which totals 8.529 acres and Tract B which totals 30.031 acres. Tract B is an old abandoned golf course and contains one upland excavated ditch located to the east of property that was determined to be a non-jurisdictional feature by draining only uplands. Tract A contains one upland excavated ditch determined to be a non-jurisdictional feature by draining only uplands and contained potential wetlands areas. Potential wetland areas lacked hydric soils and indicators of hydrology.
