C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. A prevalence of hydrophytic vegetation, multiple hydrology indicators, and hydric soils were observed within the flagged wetland boundary which was delineated by the Agent. An abrupt topographic break also contributes to the delineation of the wetland line on all sides of the property. On-site wetlands are adjacent and abutting a perennial RPW which flows within floodplain wetlands to the east and intercepts the OHWM of an off-site perennial RPW called Green Swamp on USGS Topo Maps. Green Swamp flows to the south and intercepts the OHWM of the Pocotaligo River, a perennial RPW. The Pocotaligo River flows directly into the Black River, a TNW. The perennial nature of the onsite tributary was determined by observations on the subject property. Indicators of the flow regime included: the presence of a natural sinuous channel with bed and banks within floodplain wetlands, the presence of an OHWM, the presence of flow during drought conditions, the absence of vegetation within the channel, and the presence of a sandy bottom channel. The feature was entirely natural and was approximately 3' deep by 2.5' wide and the portion on the subject property was entirely within floodplain wetlands. Topographic maps do not depict this reach. Aerial photos do not show the presence of a defined stream channel because of canopy cover. No other potentially jurisdictional aquatic features were discovered during the investigation.
