**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Area in review contained no Waters of the U.S. or isolated wetlands. This site is comprised of Leon soils that are hydric although soil samples lacked any evidence of hydrology. Soils onsite contained high chromas, were very sandy falling out of the auger, and no hydrology was present. Additionally, Georgetown county NWI data depict the site as U42P which are uplands. The project site was approximately 2500 linear feet from the nearest WOUS feature visible on aerial photography. USGS topographic information and aerial photography depict the site as being a well drained upland area with a mixture of forested and unforested ground cover adjacent to several residential and commercial lots.
