**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** No jurisdictional wetlands were found on the subject property. A review of the NWI shows the site mapped as uplands (U21) with no wetland areas on the subject tract. Additionally, the soil is bright and the Orangeburg County Soil Survey has the site mapped as non-hydric units Noboco, Dunbar and Duplin. An upland dug man-made conveyance, approximately 300 feet long, 3 feet deep and 5 feet wide, was noted running diagonally from southeast to northwest along the northern third of the subject property. This feature was dry at the time of the site visit, but showed no ordinary water mark and no evidence of recent flow, and was therefore determined to be non-jurisdictional.
